



General Meeting Minutes

Yavapai College, Bldg 104, Rm 102

June 8, 2016

Meeting called to order at 6:00 p.m. with Sondra Bradshaw presiding. We had twelve people in attendance. George Harrell, visitor, became a member.

In the place of a presentation, we had our semi-annual Genius Bar. Art Gorski and Ward Stanke were our panel participants this time. Questions were submitted to the panel from members. Following are a summation of the questions and the answers.

Genius Bar Questions June 2016

Jim Hamm:

I use the Browser version of Gmail. Let's say I send an email to Bobbie and BCC myself. My copy of the sent email always goes into the Primary Inbox. I would like my BCC copies always go into the Social Inbox. How can I get this to occur?

If, say, I get an email from someone that I haven't received an email from previously, it goes into my Primary Inbox. If I want future emails from that person to go into my Social Inbox I can right-click and say move to social. Gmail then asks if I want future emails from this address to go into Social Inbox. I click yes. But Gmail doesn't ask me this question for my own emails.

Obviously a major, deleterious and unforgivable deficiency in Gmail...😞 ...Jim

David Passell:

On April 2 I decided to simplify my interfaces by connecting my mini directly to one of the ethernet ports on my Time Capsule; it is connected to my cableone modem, and after all it is a router. That meant i disconnected an older linksys router from the chain.

Everything seemed to be OK and i did my usual things on the internet.

In May I received a letter from Cableone that told me i had exceeded my bandwidth by 213%. I went to my cableone account for "mybandwidth" and sure enough. I was uploading and downloading large amounts of data.

I put the router back into the chain and after a couple of days checked bandwidth usage again and found it back to what it was before i had removed the router.

I don't know how much detail to provide here but briefly:

before: cable > modem (ethernet) > time capsule > linksys router > mini.

after: cable > modem > time capsule > mini.

the attachment shows the before, during (sparing you the April/May usage) and after usages.

I hope i hadn't become someone's "bot"; but something happened. My guess is that i started continuously sending/receiving data to myself though i don't know why.

This may be useful to others who use Cableone who might also want to check their bandwidth usage and net configuration; especially if high bandwidth usage is reported.

It might even be important enough to post on the newsletter.

Note: Cableone didn't charge me any more than the usual \$55.00 during that period.

I have a long winded question about printing. Here is what happens :

I am typing up, say, a recipe to later print out. Every once in a while a line, or part of a line will jump to the right of the page and then has to be brought back to the body of whatever is being typed. Then when the image of what you have just done comes up in "print" it shows the image with the jumped lines even though the original has been corrected, and if you print it out, there are the jumped lines. There seems no way to correct it except to type it over and hope you don't make a mistake because the mistake is what is going to show on the print out no matter that you've corrected it. Help!!!

My hard drive is almost full on my macbook Pro and i have not been able to find what is using all the space, what do i need t do?

Run OmniDiskSweeper or a similar utility.

Sondra Bradshaw:

Please explain the purpose of Keychain, and how do I know it is active and working on my computer. In the Keychain column, there is *Login* and *Local Items*. Please explain these. In the *Category* column, would I use *All Items*, or just *Passwords*?

You should never need to run Keychain Access. It's where all your passwords and certificates are stored and is maintained automatically by OS X. For example, when you go to a website in Safari it will automatically fill in the login fields for you. Personally, I've turned off this option in Safari and use 1Password to manage all my passwords.

Bobbie Pastor:

When I *Airdrop* files from another device or computer, where can I find them on the Mac? Images as well.

On a Mac, they go into the Downloads folder. On iOS, they go into the private storage for a particular app. For example, Photos appear in the Photos app.

I am confused about *Apple Pay* and *Wallet*. Are they two different things? How do you set them up on your iPhone?

Wallet is an iOS app that holds things like boarding passes, rewards cards from Fry's, and credit and debit cards.

an AppleID associated with it, which is the individual account that Apple maintains for one person.

Family Sharing is Apple's way to allow interaction between people and share resources.
